मुरादनगर के समीर हत्या का मास्टरमाइंड निकला पूर्व विधायक चौधरी, पुलिस ने किया खुलासा ने अहद और उसके दोस्त आफताब को किया गिरफ्तार

मुरादनगर थाना क्षेत्र में रविवार को हुए समीर हत्याकांड में पुलिस ने मरादनगर के पर्व विधायक वहाब चौधरी व उनके भतीजे अहद व उसके दोस्त आफताब को गिरफ्तार कर लिया है। पुलिस का दावा है कि वाहब चौधरी ने ही अपने भतीजे अहद को न केवल युवक की हत्या करने के लिए उकसाया था बल्कि अपने पुत्र आदिल से पिस्टल भी उपलब्ध कराया था। वहाब चौधरी बहुजन समाज पार्टी से मुरादनगर के विधायक रह चुके हैं। दरअसल मुरादनगर के क्षेत्र के प्रीत विहार में खाली पड़े प्लॉट में शहजाद अंसारी के पुत्र समीर की लाश बरामद हुई थी। समीर की हत्या गोली मारकर व सरियों से हमला की गई थी। शहजाद अंसारी ने वहाब चौधरी के भतीजे अहद व तीन अन्य दो अज्ञात लोगों को खिलाफ रिपोर्ट दर्ज कराई थी।

शहजाद ने अपनी तहरीर में कहा था कि वहाब चौधरी का भतीजा अहढ व उसके तीन अन्य साथी समीर को घर से बुलाकर ले गए थे लेकिन वह घर नहीं लौटा, तो उसकी तलाश की गई। रविवार को उसका शव खाली पड़े प्लॉट में मिला। पुलिस अधीक्षक ग्रामीण डॉ. इरज राजा ने प्रेसवार्ता में बताया कि मृतक समीर व वहाब चौधरी का भतीजा अहद आपस में दोस्त थे। कुछ माह पूर्व चौधरी के भाई आस मोहम्मद उर्फ डॉन की पत्नी की हत्या गोली मारकर कर दी गई थी। इस हत्याकांड में आस मोहम्मद, उसका बेटा अहद व मृतक समीर जेल गए थे। आस मोहम्मद अभी जेल में ही बंद है जबिक समीर और अहद करीब ३ महीने पहले जेल से जमानत पर छूटकर आए थे। पुलिस ने इलेक्ट्रॉनिक सर्विलांस,मैन्युअल इंटेलिजेंस, भौतिक व परिस्थिति जन्य साक्ष्य के आधार पर अहद के ताऊ व पूर्व विधायक वाह चौधरी को गिरफ्तार कर लिया।

पूछताछ में अहद ने पुलिस को बताया किं प्रीत विहार कब्रिस्तान के पास ज्वार के खेत में उसकी पहले पिटाई की। उसके बाद गोली मारकर हत्यां कर दी और फरार हो गए। राजा ने बताया कि इस मामले में तीन अन्य आरोपी अनस आदिल वह नदीम और घोडा फरार हैं जिन्हें जल्द ही गिरफ्तार कर लिया जाएगा। उसके ताऊ वाह चौधरी ने कुछ दिन पहले उसे अपने घर बुलायाँ था।
