\* The Hon'ble High Court of Delhi vide their order CS(OS) 3506/2012 dated 21.12.2012 restrained Mr. Jang Bahadur Singh ('JBS') (Folio No. J-324) from exercising voting rights on the shares of Frick India Limited (FIL) registered in his name to the extent of 20% shareholding in FIL constituting 120,001 (One Lac Twenty Thousand One) equity shares in number (i.e. 50% of total shares held by JBS), in the Annual General Meeting of FIL held on 29th December 2012, and in all future meetings and also granted interim relief by ordering that the said voting right shall be available to the benefit of Mr. Jasmoan Singh and his siblings namely Mr. Gurmohan Singh, Ms. Jasleen Kaur and Ms. Gurleen Kaur and Mr. JBS is further restrained from executing any instrument of whatsoever nature dealing with or otherwise creating or transferring any right, title or interest in respect of said 20% shareholdings in FIL in favour of any third party. This is for necessary information and records.
